Perform monthly and annual maintenance services to Hoapili Hale's (Wailuku Courthouse) Cummins emergency generator system that provides electrical power during a utility power outage.

6. Describe in detail the following:

a. The unique features, characteristics, or capabilities of the goods, service or construction.

King Power Systems Inc. "KPS" is the original installer of the Cummins emergency generator at Hoapili Hale (Maui's main courthouse). KPS is the only Cummins Power Generation factory dealer for Maui County, Hawaii and employs factory trained and certified technicians, drawing upon more than half a century of experience in the field. Cummins Power Generation equipment and components can only be purchased through Maui County Exclusive Dealer-King Power Systems Inc.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department.

Maintenance of the emergency generator is essential to the day to day operations at Hoapili Hale which consists of eight (8) courtrooms, and houses the the majority of supporting departments (Fiscal, Legal Documents, probation etc.) The Cummins emergency generator is the only power backup system to support the Second Circuit's Wailuku Courthouse emergency lighting and elevators.

7. Describe the efforts and results in determining that this is the only vendor/contractor/service provider who can provide the goods, services or construction:

Based on King Power Systems Inc. sole source letter dated August 2, 2024, KPS is the only Cummins Power Generation factory dealer for equipment and components in Maui County, Hawaii. KPS has been providing Cummins generators, parts, and service since 1978 and employs factory trained and certified technicians.
