COURT INTERPRETER MILEAGE REIMBURSEMENT

**Increases to \$0.67/mile
Effective July 1, 2024**

WHO CAN CLAIM MILEAGE REIMBURSEMENT? HOW MUCH CAN I CLAIM?

- Mileage reimbursement rate is set at **\$0.67/mile**, effective **07/01/24**.
- Court interpreters may claim roundtrip mileage from their home address to the court assignment location and back, rounded up to the next whole mile.
- Use *Mileage Chart* to calculate your mileage reimbursement amount.

HOW DO I CLAIM MILEAGE REIMBURSEMENT?

- On the “Invoice for Interpreting Services” (Interpreter Invoice) form, Line 4, write in: Roundtrip miles, Location of court assignment, and Mileage reimbursement amount.
- Mileage reimbursement claims will only be processed if a residence address is recorded with the Judiciary’s Office on Equality and Access to the Courts (OEAC).

HOW DO I UPDATE MY RESIDENCE ADDRESS ON FILE?

- It is the interpreter’s responsibility to ensure that OEAC has their current contact information.
- Contact OEAC to update your address information.

HOW TO USE THIS MILEAGE WORKSHEET:

STEP 1: Find the mileage from your house to the court using internet services.

- You can use Google Maps or another service. These instructions are for Google Maps.
- Click on  “Get Directions” icon in search bar at top of screen.
- Make sure the  “Driving” icon at the top left of the screen, is selected (it will be shaded).
- In the top box (“Choose starting point”), type in your home address, city, state, and zip code.
- In the bottom box (“Choose destination”), type in the court/program address from the chart.
- When you hit the “Enter” button after entering your destination address, it will automatically calculate mileage. Mileages for several different routes may be shown. **USE MILEAGE FOR SHORTEST ROUTE.**
- Multiply the mileage shown times 2 (for roundtrip), then round up to the nearest whole number, and then enter the result in “**Total Roundtrip Miles**” column.

STEP 2: Calculate the mileage reimbursement amount you can claim on your invoice.

- Multiply Total Roundtrip Miles by \$0.67/mile (mileage rate) and enter the result in “**Total Mileage Reimbursement**” column.

Step 3: Use this chart to complete the “Mileage” section of the *Invoice for Interpreter Services* form.

- To complete the Standard Invoice: Find the court location on this chart. Enter the “**Total Roundtrip Miles**” and “**Total Mileage Reimbursement**” amount from this chart on the *Standard Invoice* form.
