Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means: The SPARK Project requires a youth to learn a new skill or participate in an activity that provides the Spark that uncovers their innate potential through a better understanding of themselves or others so they may reduce their engagement in delinquent behaviors such as substance use, and increase their engagement in protective factors. A youth's SPARK Project may require participation in the evenings, on weekends, and access to a location near the youth's residence. It is not practical nor advantageous for Family Court, Juvenile Client Services Branch to procure youth membership by competitive means because YMCA provides various teen activities island wide with seven (7) convenient locations with extended hours to include, evenings and weekends. The membership will allow a youth access to all seven (7) YMCA locations on Oahu. The YMCA provides various activities to ensure a youth can complete their SPARK Project requirements. Such activities include academic support, junior leadership, enrichment classes, social activities, and activities for fitness, exercise, art, music, dance, swimming and sports. YMCA also offers access to virtual live streaming and on-demand fitness, sports & youth classes to allow youths who lack transportation the ability to complete the SPARK Project requirements. YMCA amenities vary by location to include heated pools, locker rooms, saunas, basketball, pickleball, and racquetball.

Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider: An online research of agencies that may provide similar services was conducted, but no other agency met the needs of the request. The vendor listed above is the only vendor able to provide the services which include academic support, junior leadership, enrichment classes, social activities; various activities to build skills such as art, music, dance,fitness, swimming and sports; available in the evenings, weekends and various locations island wide to meet the needs of Youth Memberships for Family Court youth to fulfill their SPARKS project.
