a. The unique features, characteristics, or capabilities of the goods, service or construction.

The HI-SCAN 7555si is an upgrade to our existing HI-SCAN 7555i. The HI-SCAN 7555si X-Ray machine has enhanced image resolution that provides extremely detailed images and better detection capabilities for wires and denser metals.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department.

Provides added security for our facility and staff. The X-Ray machine is essential to maintain efficient and thorough screening at our main entrance screening checkpoint.

7. Describe the efforts and results in determining that this is the only vendor/contractor/service provider who can provide the goods, services or construction:

Our current maintenance contract is with Smiths Detection. Smiths Detection has provided prompt and reliable service over the years, as well as maintain the rest of our X-Ray machines and walk-through metal detectors. Smiths Detection is the sole manufacturer of the HI-SCAN 7555si and the only authorized company to service the equipment and software included with this system in Hawaii. Smiths Detection's products, software and services are protected by trade patents and cannot be duplicated for any reason.

8. Alternate source. Describe the other possible sources for the goods, services, or construction that were investigated but did not meet the department's needs.

There are no other possible sources for the goods and services. As stated in the sole source confirmation letter dated February 3, 2025, Smiths Detection products, services and software included with the system is protected by specific trade patents and cannot be duplicated for any purpose. Smiths Detection is the sole manufacturer of the HI-SCAN 7555si which provides enhanced image resolution, extremely detailed images and better detection capabilities for wires and denser metals. Smiths Detection has no authorized representative in Hawaii for its products and services at this time. These products, services, and software are only available through Smiths Detection in Hawaii.
