Allowing another vendor to work on the Fifth Judicial Circuit air conditioning and ventilation system exposes the Judiciary to potential multi-vendor conflicts which may impair the functioning and maintenance of the ventilation and air conditioning systems. Oahu Air Conditioning Services, Inc. was the responsible party who found additional leaks during economizer gasket replacement. Having another vendor provide the repairs may incur additional costs to the Judiciary for them to conduct an assessment of the air conditioning and ventilation system.
