

How to Get Your Purchased Documents

Important: You have two days to download your purchased documents.

Once you complete the document purchase process, you can download documents as soon as you receive the receipt via e-mail. The Purchase ID and the email address will already be filled in on the View / Purchase Documents screen **as long as you do not log out of the online purchase session.**

If you have logged out of the online purchase session, please refer to the Purchase Receipt sent to your email address for the Purchase ID. You will need that information and the email address associated with the transaction. Follow the steps outlined below to access your purchased documents.

I. Go to eCourt Kōkua (https://www.courts.state.hi.us)



A. Click on eCourt Kokua* link.

B. Scroll down and click on "Click Here to Enter eCourt* Kokua" button.
