Due to proprietary components of the XIS, only Astrophysics certified service technicians can install and provide warranty services for these systems using certified products, accessories and software. Damage resulting from service, testing, adjustment, installation, maintenance, alteration, or modification by someone other than an Astrophysics certified service technician or using non-Astrophysics branded or certified products, accessories, software, or peripheral equipment are excluded from coverage and may void the warranty in its entirety.  b.
