

## **SMALL CLAIMS ODR PILOT PROGRAM TO END ON JUNE 30, 2025**

### **Next Steps for Users:**

- **Cases filed through June 30, 2025:** All cases filed through the Small Claims ODR platform before June 30, 2025 will continue to be processed online until 11:59 pm HST June 30, 2025. After June 30, 2025, all filings will revert to conventional methods, i.e. filing at the courthouse. All open online negotiations will also expire at 11:59 pm HST June 30, 2025.
  - **Please print and save to your device all your documents filed through the Small Claims ODR platform. The last day to save and/or download your filings will be on September 30, 2025. There is no added cost to you for downloading your documents from the Small Claims ODR platform.**
  - After September 30, 2025, you may obtain a copy of any filed documents through the [eCourt Kokua](#) website. Please be aware that there is a cost for obtaining copies from eCourt Kokua or at the courthouse.
- **New cases after June 30, 2025:** The Small Claims ODR platform will no longer accept new and/or subsequent case filings after June 30, 2025. Individuals who want to file a small claims have the following options:
