a. The unique features, characteristics, or capabilities of the goods, service or construction.

Originally installed at Ali'iolani Hale in January 2005, and then expanded include the Kapuaiwa Building in February 2006, the Proximity Access Identification Card System (System) allows users access to the building by scanning their Judiciary issued ID badges with any access control reader programmed for authorized entry.

The original access control readers for the Kapuaiwa basement were wireless devices transmitting its access signal to communicate with the head end on the first floor. Over the years, the replacement models were slowly transitioned over to hard-wired readers as it is considered the best practice. A new access control head end in the basement is needed to support these newer models and to provide seamless expansion for the future.

The recently installed intercom system in the basement has been working in satisfactory condition. However, a door release mechanism is now needed to provide internal users the ability to electronically open the access controlled door allowing authorized access for employees and visitors into the basement level.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department. Prior to 2005, traditional metal keys were used entirely for this building. Whenever a key was lost, replacement of locks/keys were always a serious consideration as security is a high priority, since the Supreme Court is housed in Ali'iolani Hale. Between 1995 and 2005, several vital master keys were lost resulting in significant replacement costs.

With the introduction of the System, access control readers were installed at strategically placed locations throughout the building, concentrating on the perimeter entrances and confidential areas. Proximity access badges (PAB) were issued to all employees and programed to provide access based on their job description. The PAB also doubled as a new Judiciary identification badge, replacing the antiquated version as employee information and their photo could be printed directly onto the access card. If a PAB is accidentally lost, the System administrator would simply deactivate the PAB preventing any unauthorized access. Replacement locks or keys would not be needed. The cost to replace a PAB is \$6.
