a. The unique features, characteristics, or capabilities of the goods, service or construction.

Our access control system uses Lighthouse and Premisys to control access through out the facility. Lighthouse is primarily used in our cell block area to control cell doors and sallyport gate for transporting custodies. Premisys is mainly used to control access for the staff within the facility as well creating badges and reports. Our American Dynamics Video Managment System is also integrated into Lighthouse providing access to live video of all the surveillance cameras throughout the interior and exterior of the property.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department.

The access control and video surveillance are essential to providing the tools needed to safeguard our facility. The integration of video and access control allow Lighthouse to monitor public high traffic areas and also automatically call up cameras in the vicinity when a duress button is activated. Premisys provides access control through customizable access groups and timezones for various departments and staff.

7. Describe the efforts and results in determining that this is the only vendor/contractor/service provider who can provide the goods, services or construction:

Security Resources is the only authorized vendor to service and maintain the Lighthouse/Premisys access control system along with the PremiSys interface to the American Dynamics Video Edge Management System and the related interface software and hardware. Premisys does not provide products or support to unauthorized companies.

8. Alternate source. Describe the other possible sources for the goods, services, or construction that were investigated but did not meet the department's needs.

NA - Security Resources Pacific is the only authorized vendor to service and maintain the Lighthouse/Premisys access control system in Hawaii.
