Material and labor to install a new contactor. Scope of work includes: remove/disconnect existing starter contactor; mount new contactor in designated location; connect the input power supply and output motor leads per manufacturer specifications; integrate control wiring with the elevator control system ensuring proper interfacing; perform testing to ensure proper start up; adjust parameters for optimal performance and release back to service

4. Explain in detail what is being amended:

Requesting additional funding of \$5,364.81 to repair private elevator #7 at Ka'ahumanu Hale; contract to increase from \$715,768.60 to \$721,133.41.

5. Amended contract price for this request:

\$721,133.41

6. Explain in detail why the amendment(s) are necessary:

The amendment is necessary for additional funds required to complete and pay for the repairs of private elevator #7 starter contactor replacement. The repairs will ensure the elevator is operable and functioning properly for the safety and welfare of all.
