a. The unique features, characteristics, or capabilities of the goods, service or construction.
The control console will house the equipment for for our Lighthouse/Premisys access control system that manages access throughout the facility as well as the American Dynamics Video Management System. The new control console will be custom built to fit our needs and provides flexibility in configuration options.

b. How the unique features, characteristics or capabilities of the goods, service or construction are essential for the department.
It is essential to upgrade our control console as the previous one installed was built to fit the equipment of the old access control and video systems with no room to expand to fit new equipment or monitors.

Security Resources is the vendor that maintains our access control and video surveillance systems and they are the only company in Hawaii that is authorized, certified, and trained to the Premisys/Lighthouse access control system and the Premisys interface to the American Dynamics Video Edge Management System and the related interface software and hardware
