NOTICE OF REQUEST TO AMEND AN EXEMPTION
FROM HRS CHAPTER 103D CONTRACT

Pursuant to HRS § 103D -102 (b)(4) and HAR Chapter 3-120, The Judiciary requests to amend an exempt contract as follows:

1. Exemption Reference (JE) number: JE26-13, JAE26-15
2. Vendor/Contractor/Service Provider Name: Alert Alarm of Hawaii
3. Describe the goods and/or services: To acquire the professional services of Alert Alarm of Hawaii to provide equipment and services for home alarm packages for Judiciary Justices and Judges who have been evaluated at an elevated risk of targeted violence at their residence as a result of their official duties.
4. Explain in detail what is being amended: No-cost amendment; there is no change to the contract value. This amendment revises the compensation and payment structure for Contract J26266 to add greater specificity regarding pricing. It updates and adds language to the compensation and payment schedule. The total cost of the Judiciary's Home Alarm Program shall not exceed the previously approved amount of \$975,000.
5. Amended contract price for this request: The contract price remains unchanged from the previously approved amount of \$975,000

6. Explain in detail why the amendment(s) are necessary:

JAE26-15 was approved to procure professional services from Alert Alarm of Hawaii to provide equipment and services for an estimated thirty-seven (37) home alarm packages for Judiciary Justices and Judges assessed to be at elevated risk of targeted violence at their residences due to their official duties. This amendment is required to update the compensation and payment schedule to reflect an increased number of initial home alarm packages from thirty-seven (37) to forty (40).
