This user manual provides an overview of the functionality and navigation features available in the new eCourt Kōkua.

### *About eCourt Kōkua*

eCourt Kōkua allows the public to view publicly available case information and purchase publicly available court documents. Users may also purchase certified copies of court documents online without needing to visit the courthouse.

The following types of court cases are available in eCourt Kōkua:

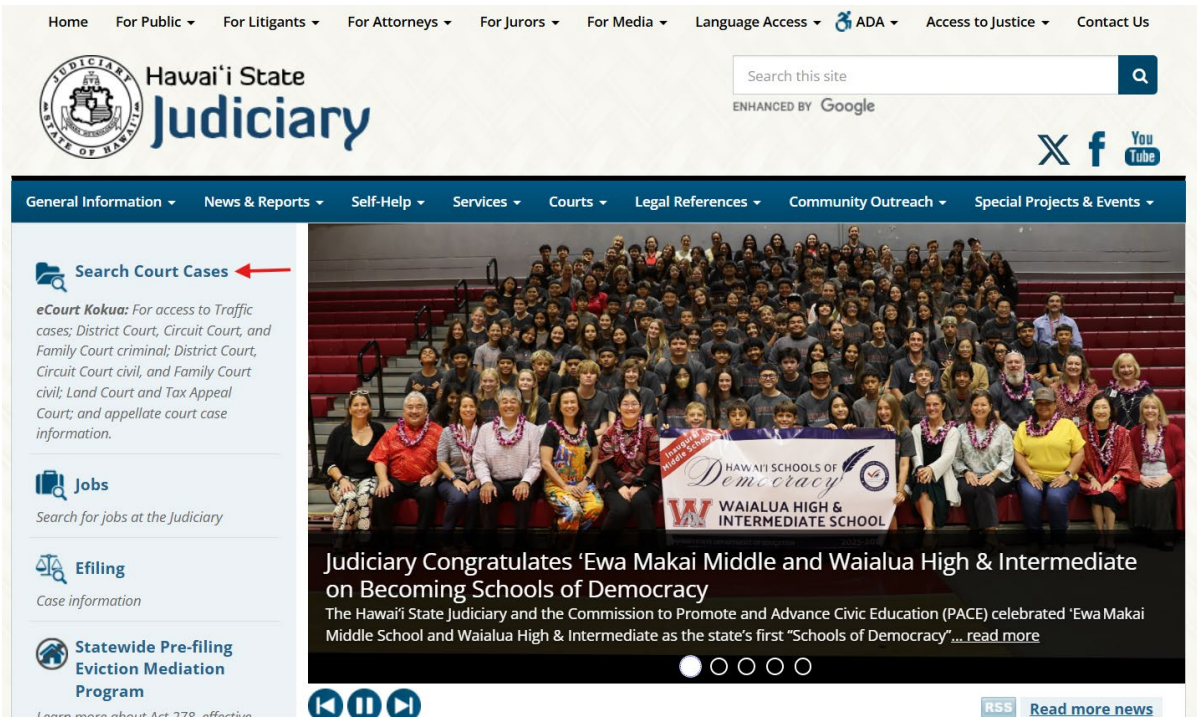
- Traffic Court
- District Court, Circuit Court, and Family Court – Criminal
- District Court, Circuit Court, and Family Court – Civil
- Land Court and Tax Appeal Court
- Intermediate Court of Appeals
- Supreme Court

Confidential, Juvenile, and Sealed cases are not available in eCourt Kōkua.

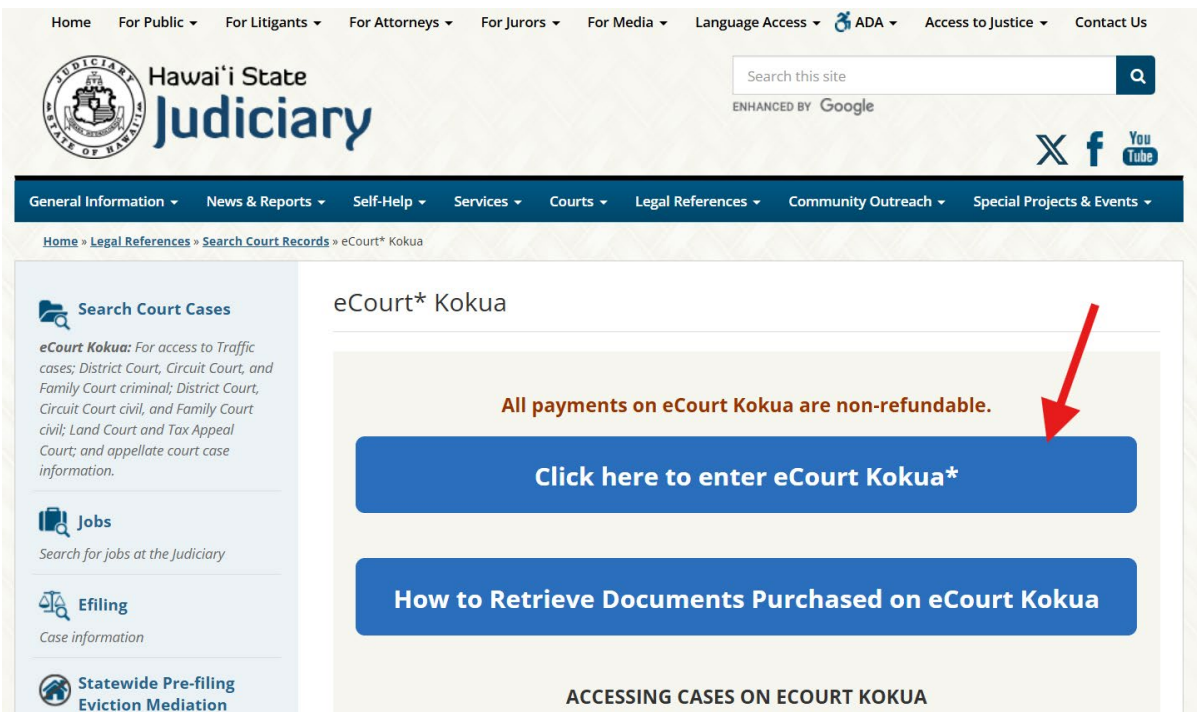
### *Navigate to eCourt Kōkua*

There are two ways to access eCourt Kōkua; the first is through the Judiciary website and the second is via JEFS.

1. **eCourt Kōkua through the Judiciary website.**

## Purpose of the Application

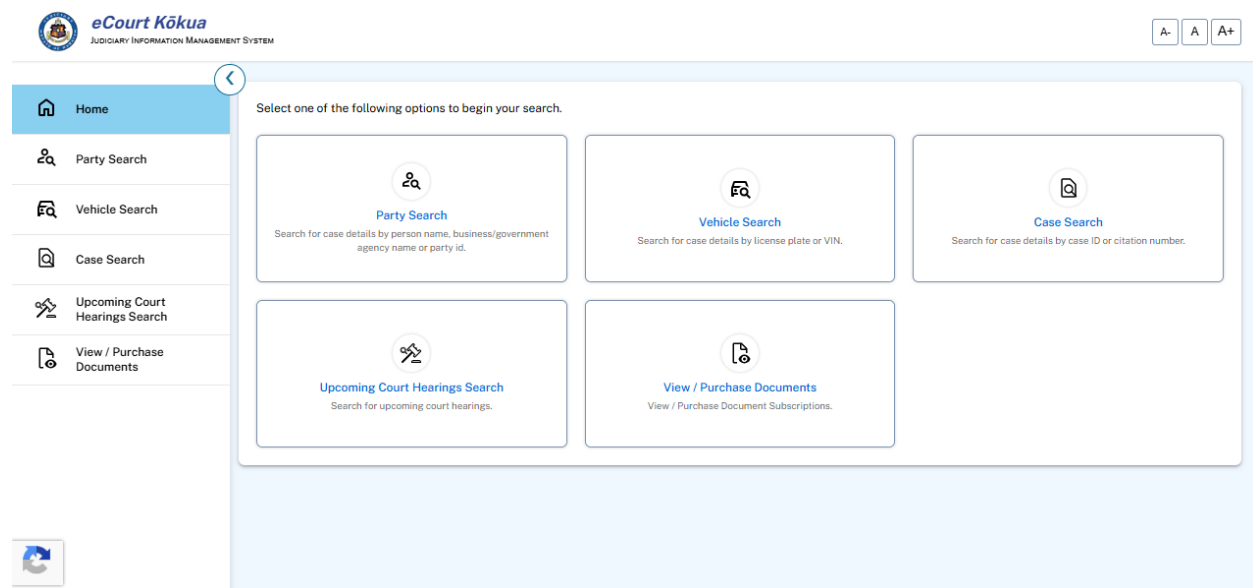
eCourt Kōkua offers multiple search options to help the public find case information. These include:

- Party Search**, which contains four subtabs: Name Search, Person Search, Company Name Search, and Party ID Search

- **Vehicle Search**, which contains two subtabs: License Plate Search and VIN Search
- **Case Search**, which contains two subtabs: Case Search and Filing Date. Both the searches include a detailed information of the searched Case ID and Filing Date of the Case.
- **Upcoming Court Hearing**, which includes two subtabs: Case ID Search and Court/Location Search. This section shows the upcoming events of the case.
- **View/ Purchase Documents**, which includes two sections: Purchased Documents and New Document to purchase.

## User Interface Overview

The Home page provides quick access to all major search functions in eCourt Kōkua. The left navigation menu displays the available search options, while the main area presents selectable search tiles.



### I. Search Tiles (Main Panel):

The central section displays clickable tiles for:

- Party Search – Search by Name Search (Last and First Name), Person Name, Company name, or Party ID.
- Vehicle Search – Search by license plate or VIN.
- Case Search – Search by case ID or citation number.
- Upcoming Court Hearings Search – View upcoming court hearings.
- View/Purchase Documents – Access or purchase documents.

## 2. Left Navigation Menu:

Provides direct links to Home, Party Search, Vehicle Search, Case Search, Upcoming Court Hearings Search, and View/Purchase Documents. The left navigation menu is in the form of a collapsible side panel.

## 3. reCAPTCHA (Bottom Left):

Ensures secure access by verifying that the user is a human before performing searches or accessing features

## 4. Search Results

Each search option shows the results that match the information you entered.

- The system displays up to 200 results at a time.
- The results appear in a table that includes page buttons so you can move through the list.
- By default, 20 results per page are shown. You can change this number using the Show dropdown.

If your search returns more than 200 results, the system will load the next set of 200 results upon clicking the Load More button.

## Party Search

Party Search provides 4 different Party related search options:

- **Name Search**
- **Person Search,**
- **Company Name Search,** and
- **Party ID Search.**

When using Name Search, Person Search or Company Name Search, users can select a Party ID from the search results to navigate to the Party ID Search screen. This screen displays all publicly available cases in eCourt Kōkua associated with that party.

## I. Name Search

Name Search allows the user to search for a party or business entity based on their name, the filing date of their case, and the case type.

- I. **Person** – select when searching for an individual party to a case.

Use the following fields to enter party details. Providing more information will improve search accuracy.

- Last Name (\*) – Required for person searches
  - a. First Name (\*) – Required for person searches.
  - b. Middle Name – This is an optional field. Provide the middle name to improve precision
  - c. Check for Phonetic Search – finds names that sound similar to the entered name (useful for spelling variations).
  - d. Check for Partial Search – returns results that partially match the entered text (useful when the full name is unknown).
  - e. Beginning Case Filing Date – the start date of the range; include cases filed on or after this date.
  - f. Ending Case Filing Date – the end date of the range; include cases filed on or before this date.
- Case Type - Select the category of cases (e.g., DV, AB etc.) to narrow the search to relevant records.

- II. **Business / Government Agency** – select when searching for an organization or government body.

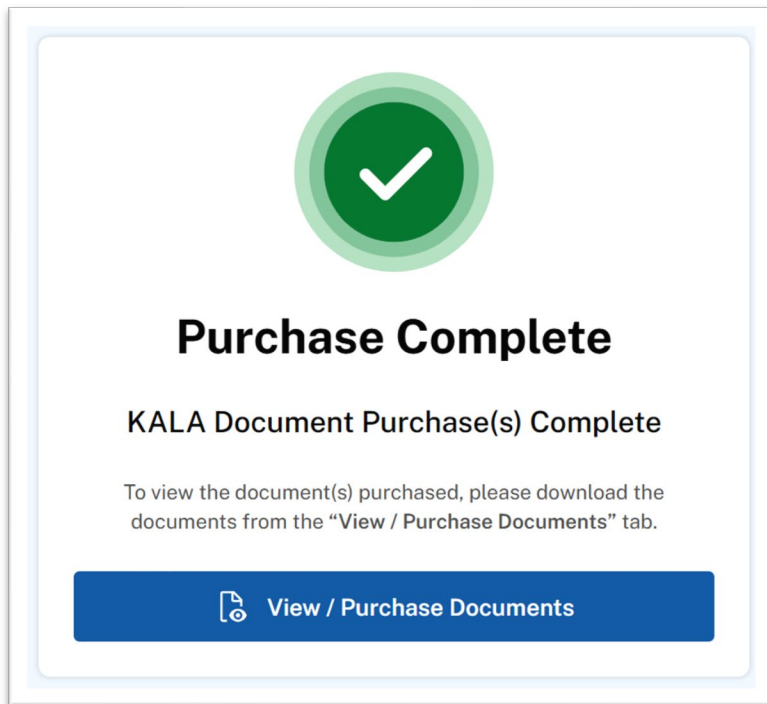
