Explain in detail why it is not practicable or not advantageous for the Program/Division to procure by competitive means: All software that monitors the fire alarm system at Kapolei Judiciary Complex are held by Island Signal and Sound, Inc. a Authorized Edwards Strategic Partner to sell, order, install, maintain, and service all Edwards Fire and Life Safety products in Hawaii. If the Judiciary were to go out and bid for another vendor to install a software comparable to the system already in place. It would mean additional cost besides the annual service maintenance, it would also mean a higher cost on a annual basis. Island Signal and Sound, Inc. is the original fire alarm vendor which furnished and commissioned the fire alarm system at Kapolei Court Complex.</p>

Explain in detail, the process that will be or was utilized in selecting the vendor/contractor/service provider: Island Signal and Sound, Inc. were the initial vendors that delivered the Edwards Strategic system that the Judiciary had already envisioned to have at Kapolei Judiciary Complex. During construction period of Kapolei Judiciary Complex in 2009, General contractor of KJC, Constructors Hawaii subcontracted the designing and installation of fire alarm system to Island Signal and Sound who in turn completed the project with all of their Edwards Strategic authorized equipment. As a Factory Authorized Edwards Strategic Partner in the state of Hawaii is the reason the Judiciary has chosen Island Signal and Sound Inc.</p>
